The above-named applicant is applying to the Sexual Health and Harm Reduction Program Getting to Zero Initiative's Youth and Young Adult Advisory Board, sponsored by the County of Santa Clara's ("County") Public Health Department. By signing below, I understand and agree to the following:

- ❖ All Youth and Young Adult Advisory Board participants are required to submit to the County a(n) volunteer application, health clearance form with proof of Covid-19 vaccination or exemption, and emergency contact. Applicants older than 18 years must consent to a background check.
- ❖ Any false information provided to the Youth and Young Adult Advisory Board, whether during the application process or while participating on the Youth and Young Adult Advisory Board, may result in that individual's elimination from participation in the Youth and Young Adult Advisory Board and/or its activities.
- ❖ If selected to serve on the Youth and Young Adult Advisory Board, the applicant may participate in all Youth and Young Adult Advisory Board activities (virtual and in-person), such as, but not limited to, social media content creation; community engagement and outreach events, conferences, and fairs; community presentations, workshops, and advocacy.
- ❖ Participation on the Youth and Young Adult Advisory Board is uncompensated. Participants shall bear their own costs of participating on the Youth and Young Adult Advisory Board (e.g., travel to and from local activities of the Youth and Young Adult Advisory Board).
- ❖ The County reserves the right, in its sole discretion, to terminate an individual's membership on the Youth and Young Adult Advisory Board for any misconduct.
- ❖ The County reserves the right, in its sole discretion, to modify, suspend, or terminate the Youth and Young Adult Advisory Board at any time without prior notice.

- ❖ Youth and Young Adult Advisory Board members shall not use the name or logo of the County, County’s Public Health Department, Sexual Health and Harm Reduction Program, Getting to Zero Initiative, or any other organization without that organization’s prior, written consent.
- ❖ If the applicant is selected to serve on the Youth and Young Adult Advisory Board, the County shall have the royalty-free, irrevocable right to take, duplicate, display, disseminate, publish, modify, prepare derivative works of, and otherwise use, for any purpose:
  - the individual’s name, age, and/or municipality of residence
  - the individual’s verbal and/or written statements
  - the individual’s writings and/or other creative works
  - photographs and/or digital images of the individual
  - video or audio recordings of the individual

(collectively, "Materials"). This authorization extends to use of the Materials in any manner or medium that the County deems appropriate, including, but not limited to, websites, social media applications, video, radio, newspaper, television, and/or film.

I may rescind the consent regarding the Materials at any time if compliance with that request is not unreasonably burdensome to the County or unlawful. I also understand that rescission of my consent will not affect any uses of the Materials that have occurred before I notify the County of my decision to rescind consent. I understand that, to rescind my consent, I must contact the County at [GettingtoZeroSCC@PHD.SCCGOV.ORG](mailto:GettingtoZeroSCC@PHD.SCCGOV.ORG).

I, and each of my respective heirs, successors, and assigns, waive, release, forever discharge and covenant not to make a claim against or sue the County or any of the County's employees, agents, officers, directors, representatives, successors or assigns (collectively, the “Advisory Board Sponsor”) for any claim, liability, loss, injury or damage arising out of, or in connection with participation in the Youth and Young Adult Advisory Board, or use of the Materials as described above. I agree to indemnify and hold harmless the Advisory Board Sponsor from and against any liabilities, losses, claims, injuries, damages, demands, costs (including, without limitation, reasonable attorneys’ fees) and expenses arising out of or in connection with participation in the Youth and Young Adult Advisory Board.
